From opening its doors in 1903 when George Town was formally recognized as a British Port of Registry, and registering its first vessel, the 54-GT schooner "El Paso" then registered later that same year, the 32-foot "Lady Smith" built in Bodden Town by James Levy for Thomas Connor, to being the leading superyacht register in the world it is today, the Cayman Registry continues to adapt to global changes in the maritime industry focusing on quality products and services.

The Cayman Islands has a rich maritime history, the basis on which the ethos of the modern-day Cayman Registry was formed. Taking this heritage, Cayman Registry has translated it into the development and operation of a modern, world class, international registry, with the vision of continuing to grow as an international shipping centre.

From its inception in 1903, the Cayman Registry evolved from its primary function being vessel registration to the implementation of other services, including its own survey and inspection functions, enabling the Cayman Islands to receive Category One status from the UK in 1991. This designation allows the registration of vessels of any age, class and size, from small yachts to super tankers, provided quality standards are met. This categorisation shows complete compliance with the most important seafaring practices.

Today, Cayman Registry, a division of the Maritime Authority of the Cayman Islands (Cayman Maritime) operates as a Flag State with over 2,350 vessels on the Register totaling a gross weight of more than 5 million gross tons. In addition to registering



vessels, the registry services include vessel mortgage registration, vessel survey & certification, crew documentation, vessel construction supervision and maritime consultation – which provides oversight/guidance on maritime affairs, maritime laws and regulations.

Known for its expansive expertise and quality focus, the Cayman Registry is involved in the construction of more than 50 percent of all the superyachts currently under construction and is helping to lead the way for the development and upkeep of regulatory frameworks and codes to ensure they can adequately deal with new design-ideas. The Cayman Registry contributed to the development of specific international Yacht Codes that allow yachts to charter globally, including the Red Ensign Group Yacht Code and the Cayman Yacht Code.

Currently, the Cayman Flag has a market share of approximately half of the world's superyachts in service and 80% of the global market share of ultra-large superyachts.

Technical Format Requirements

 Photo submissions must be in JPEG format, maximum size of 10MB megabytes or smaller, but photo size must be no smaller than 1024×768 pixels (a smart phone photo will be sufficient).



- Submissions should not have any visible watermarks, signatures, or personally identifiable information.
- Retouching of Photos: The submitted photograph cannot be significantly retouched: nothing in the photograph (people, animals, scenery, objects, etc.) may be altered, removed, augmented or rearranged. Cropping is permitted, as is modest darkening or lightening of parts of the image.

Eligibility

- Contestants must be between 13 and 17 years old on the date of entry into the contest. Parental or legal guardian consent is required. Contestants must be residents of the Cayman Islands and must be lawful permanent residents.
- The individual submitting the entry will be considered the contestant and will be
 the only individual eligible to compete for the prize. Organizations are not eligible
 to compete for the prize, either as an entity or through representation by an
 individual. To be eligible for the prize, the contestant must provide complete and
 accurate information.
- The following individuals are **not eligible** to participate in the contest: employees, interns, directors, and officers of the Cayman Islands Shipping Registry; or any employees, interns, directors, or officers of any agencies, companies or entities involved in the administration, advertising, judging, creation, development, execution, and/or fulfillment of this contest, and the immediate family members (defined as spouse, recognized partner, parent, child, sibling, and spouse or "step" of each) and those living in the same household of each such individual.
- Once a submission has been accepted for entry into the contest, the contestant's name (or User ID, if the contestant wishes to remain anonymous), age and school may be publicly identified at the sole discretion of the contestant.

Selection of Winners

Judging Criteria: Artwork should explore the theme of the Cayman Islands Shipping Registry, "**Navigating the Horizon**"

- Judges will award points for creativity, originality and based on how thoughtfully the artist incorporates the theme into their artwork.
- All artwork should be submitted on a standard 22" x 28" poster board and weigh no more than 2lbs.
- Contestants will submit their work to the Cayman Islands Shipping Registry office no later than 4:00pm, Friday May 14, 2023. Office Location: Unit 1 Breezy Castle, 125 Owen Roberts Drive, George Town, Cayman Islands.
- Finalists will be contacted and submitted pieces will be presented for judging and ultimately for display.

People's Choice Award: Finalists will be chosen by the above mentioned judges and displayed at the 120th Anniversary Gala of the Cayman Islands Shipping Registry. Attendees will be able to vote once for their favourite piece. The Contestant with the most votes will win the People's Choice Award.

Winners: Each finalist will be required to sign and return to Contest Sponsors a statement of eligibility and liability/publicity release and provide a brief statement about the submission; otherwise, the winner and/or finalist will be ineligible for any prize. Winners and finalists may choose to use an alias instead of their real name and may request other identifying information be kept private. Winner(s) will be contacted via email at the e-mail address they provided for registration. The inability of Contest Sponsors to contact a potential winner may result in disqualification and/or selection of an alternate winner from among all remaining eligible submissions.
